WE ENCOURAGE YOU TO READ YOUR MEMBERSHIP AGREEMENT THOROUGHLY BUT REALIZE THAT THIS IS NOT ALWAYS FEASIBLE. WITH THAT IN MIND, WE WANT TO ENSURE THAT YOU ARE AWARE OF THE FOLLOWING ITEMS THAT ARE IN YOUR CONTRACT:

- PLEASE UNDERSTAND THAT YOU ARE ENTERING INTO A LEGALLY BINDING CONTRACTUAL OBLIGATION. FAILURE TO UTILIZE THE FACILITY DOES NOT RELIEVE YOU OF THE OBLIGATION TO PAY YOUR MONTHLY DUES.
- THERE IS AN “ENHANCEMENT FEE” OF \$39.00 INCLUDED IN THE AMOUNTS DUE FOR YOUR MEMBERSHIP. IT WILL BE CHARGED, ALONG WITH YOUR REGULAR DUES, 6 MONTHS AFTER THE START OF YOUR MEMBERSHIP AND ANNUALLY THEREAFTER.
- EACH MEMBER IS ASSIGNED A UNIQUE BAR CODE THAT MUST BE SCANNED AT THE FRONT DESK EACH TIME YOU ENTER THE FACILITY. IF NEEDED, REPLACEMENT BAR CODES ARE AVAILABLE AT THE FRONT DESK.
- FOR SECURITY PURPOSES, WE ENCOURAGE YOU TO HAVE YOUR PICTURE ON FILE AT THE FRONT DESK.
- UPON COMPLETION OF YOUR INITIAL TERM, YOUR MEMBERSHIP WILL AUTOMATICALLY RENEW ON A MONTH-TO-MONTH BASIS. SHOULD YOU NOT WISH TO CONTINUE AFTER THE INITIAL TERM, YOU WILL NEED TO NOTIFY US IN WRITING PRIOR TO THE END OF THE INITIAL TERM. NOTICE MAY BE SUBMITTED TO THE ADDRESS LISTED BELOW, IN PERSON AT THE FRONT DESK (SIGNATURE REQUIRED), BY FAX TO THE NUMBER LISTED BELOW, OR BY EMAIL TO INFO@DDAONLINE.COM
- IF THE INITIAL TERM OF YOUR MEMBERSHIP IS 12 MONTHS OR MORE, YOU MAY “FREEZE” YOUR MEMBERSHIP FOR PERSONAL REASONS FOR UP TO 3 MONTHS WITHIN A 12-MONTH PERIOD. THERE IS A FREEZE FEE THAT WILL BE CHARGED INSTEAD OF YOUR REGULAR DUES AND YOUR MEMBERSHIP WILL BE EXTENDED BY THE LENGTH OF THE FREEZE.
- PLEASE SUBMITTED WRITTEN REQUESTS FOR ANY FREEZE A MINIMUM OF 7 DAYS PRIOR TO YOUR BILLING DATE TO AVOID ISSUES. WE WILL NOT BACKDATE A FREEZE SHOULD YOU FAIL TO PROVIDE US WITH TIMELY NOTICE.
- PRIOR TO THE COMPLETION OF YOUR INITIAL MEMBERSHIP TERM, AGREEMENTS ARE CANCELLABLE ONLY AS PROVIDED IN YOUR AGREEMENT. THE TERMS ARE AS FOLLOWS:
 - PERMANENT OR TEMPORARY DISABILITY AS EVIDENCED IN WRITING BY A PHYSICIAN.
 - PERMANENT RELOCATION OF THE MEMBER’S RESIDENCE BY 25 MILES OR MORE FURTHER FROM THE LOCATION OF THE CLUB. WRITTEN 3RD PARTY CONFIRMATION OF THE RELOCATION AND PAYMENT OF A RELOCATION FEE OF \$50.00 MUST BE SUBMITTED PRIOR TO CANCELLATION UNDER THIS TERM.
- UNDER NO CIRCUMSTANCE MAY PARENTS/LEGAL GUARDIANS LEAVE THE FACILITY WHILE THEIR MINOR CHILDREN, UNDER THE AGE OF 16, ARE ANYWHERE ON THE PROPERTY.
- FOR THE PRIVACY AND SECURITY OF OUR MEMBERS, USE OF CELL PHONES/CAMERAS ARE NOT PERMITTED IN LOCKER ROOMS OR AREAS WHERE CHILDREN ARE PRESENT.
- SHOULD YOU WISH TO BRING A GUEST TO THE CLUB, WE ENCOURAGE YOU TO DO SO, BUT PLEASE BE ADVISED THAT THERE WILL BE A FEE CHARGED FOR YOUR GUEST TO UTILIZE THE FACILITY.
